Welcome



History

The Pacific Council on International Policy has been shaping the West Coast's role in global affairs since 1995.

Founded in partnership with the Council on Foreign Relations (CFR) in New York and the University of Southern California (USC) in Los Angeles, the Pacific Council emerged at a pivotal moment: when globalization was accelerating and new voices were needed in the foreign policy arena.

Our founders envisioned a bold idea: global engagement should not be confined to the Washington–New York corridor. The West Coast, with its economic power, cultural influence, and global outlook, had a vital role to play in shaping smarter, more inclusive U.S. foreign policy.

As a membership-based organization, the Pacific Council was designed to bring foreign policy out of the halls of government and into the hands of leaders across sectors: business, media, politics, academia, and law.

Since its founding, the Council has convened high-level dialogues on international issues, facilitated expert working groups, and built a dynamic network of globally minded professionals. Its members include current and former diplomats, CEOs, journalists, policymakers, scholars, and change-makers committed to deepening global understanding and advancing effective U.S. engagement in the world from the unique perspective of a West Coast lens.


MEMBER PORTAL

Code of Conduct

The Pacific Council on International Policy is committed to maintaining a civil and respectful environment as we carry out our mission to build the capacity of Los Angeles and California for impact on global issues, discourse, and policy.

To advance its Mission, the Pacific Council on International Policy must reflect the dynamism and diversity of our home region and build and maintain a community of members that fosters civil, fact-based, rational discourse on foreign affairs, global engagement, and related topics.

STANDARDS

By accepting membership of the Pacific Council, members agree to uphold the Council's values and comply with the following standards both in their Pacific Council participation and in public activities in which their association with the Council may reflect on or impact the Pacific Council's mission, values, or reputation. All provisions apply to both online and in-person activities. Members must also ensure that their guests abide by these standards.

1. **NON-DISCRIMINATION** Members must not engage in discrimination against, express hostility toward, or engage in unfavorable treatment of others based on race, ethnicity, nationality, religion, gender, sexual orientation or identity, physical ability, any intersection of the aforementioned qualities, or any other current or emerging protected statuses under applicable law.
2. **INCLUSIVENESS** Members should do more than simply not discriminate unlawfully. Members should contribute as they can to creating and maintaining a Pacific Council that reflects and mobilizes the full spectrum of diversity.
3. **NON-HARASSMENT** Members must not engage in any form of harassment or abuse of others, including sexual harassment, unwanted physical contact, or harassment based on any protected characteristic.
4. **CIVILITY AND RESPECT**
 - a. Members must not bully, use threatening language, resort to ad hominem attacks, commit defamation, engage in irrational argument, or otherwise engage in deceptive, disruptive, or uncivil behavior.
 - b. Members should not engage in business solicitation or fundraising for other organizations at Pacific Council events or meetings.
 - c. Members are expected to maintain respectful conduct during all Pacific Council hosted and co-hosted events, webinars, meetings, and trips.

5. Members are expected to always conduct themselves with the utmost respect, and treat others with the same level of consideration and esteemed regard.

6. **Non-partisanship.** As a 501c3 organization, the Pacific Council is non-partisan. All members are expected to refrain from campaigning, fundraising, or lobbying in the context of Pacific Council events, digital platforms, and other activities, without exception. Members should recognize the critical difference between nonpartisanship and bipartisanship.

7. **Respect for Confidentiality of Events and Webinars.** Members are expected to adhere to the guidelines set for all events organized by Pacific Council that are exclusive to our members and their guests. Members agree to refrain from recording and/or, unless otherwise expressly permitted by the Pacific Council, sharing any materials provided by the Pacific Council at its events.

PROCESS

By accepting membership in the Pacific Council, members acknowledge and accept (a) that compliance with the above standards is a condition of membership of the Pacific Council, and (b) that the Board of Directors of the Pacific Council has the authority and responsibility to enforce the Code of Conduct and address violations thereof as it concludes is appropriate in each case.

Members who wish to report a Code of Conduct violation can do so by contacting the Director of Membership, who will then relay the issue to the Board of Directors, Co-Chairs, and Senior Members of Pacific Council staff.

Upon receiving a report, the Board of Directors and Co-Chairs will conduct an assessment of the alleged violation, which will include an initial conversation with the member in question if the member responds to the Co-Chair's outreach.

If the Co-Chairs conclude that a violation has occurred, they will refer the matter to the Governance Committee of the Board of Directors with a recommended course of action, which may, without limitation, be no action, counseling, a written warning, limiting participation in certain Pacific Council activities for a period of time, and/or revoking membership of the Pacific Council. The Governance Committee will decide what action to take, and that decision shall be final.

Board of Directors

The Pacific Council is governed by a Board of Directors. Directors bring to the Council their experience as leaders in business, law, non-profit organizations, international NGOs, academia, and government.
