#### OVERVIEW & PURPOSE:

- The Pacific Council will convene a 6-8 day visit to Israel and Jordan: this visit will include a **6-day "Core Trip"** – consisting of visits to **Tel Aviv & Jerusalem in Israel** – along with an optional **2-night extension** to visit **Petra & Amman in Jordan**.   - The **Core Trip** (6 days on the ground) will commence in Tel Aviv on the morning of Monday, Oct 29; it will adjourn in Jerusalem on the evening of Saturday, Nov 3. Travelers participating in the Core Trip only will depart Sunday, Nov 4.
  - The optional **Extended Trip** will begin Sunday, Nov 4 and end on the evening of Monday, Nov 5 with departures on Tuesday, Nov 6.
- The Pacific Council's Country Dialogues convene focused, high-level meetings with senior business, cultural, and political leaders in countries of global strategic importance. Our delegations intend to foster a deeper understanding of international affairs and to strengthen global discourse through meetings with key political and cultural stakeholders. As Pacific Council ambassadors, delegation members will represent the West Coast's key interests and concerns in meetings with local leaders while gaining exposure to the rich cultural heritage of each country they visit.
- Please note that the Pacific Council is working with [Israel Seminar](#) – a travel agency based in Tel Aviv – to arrange this delegation visit.

#### PRICING & TRIP OPTIONS:

##### Core Trip: October 29 – November 3 (Tel Aviv-Jerusalem)

- The **\$11,850** (individual)/ **\$19,719** (couple) registration fee is inclusive of: seven (7) nights of hotel accommodations in Tel Aviv and Jerusalem from the evening of Sunday, Oct 28, through the morning of Sunday, Nov 4; airport transfers; all ground transportation; all meals; all entrance fees to cultural sites; staff support; and all logistical arrangements pertaining to the trip. International airfare is not included.

##### Core + Extended Trip: October 29 – November 5 (Tel Aviv-Jerusalem-Petra-Amman)

- The **\$14,769** (individual)/ **\$23,811** (couple) registration fee is inclusive of: nine (9) nights of hotel accommodations in Israel and Jordan with the inclusion of an extended visit to Petra and Amman, from Sunday, Nov 4, through the morning of Tuesday, Nov 6; airport transfers; flight from Tel Aviv to Eilat (economy class); all ground transportation; all meals; all entrance fees to cultural sites; staff support; and all logistical arrangements pertaining to the trip. International airfare is not included.
