TRIP INFORMATION

The Pacific Council invites you to participate in a Water Scarcity Field Foray to Sacramento, California. This 1-day trip is designed for members interested in getting more involved in our Global Water Scarcity Project work. Delegates will meet with California policymakers to learn about water-sharing disputes, take a guided tour of the contested San Joaquin-Sacramento River Delta, and meet with other area experts to discuss anticipating, preventing, and resolving water disputes. The trip will be co-facilitated by our Vice President of Initiatives, Megan Karsh, an expert in international conflict resolution, and partners in the State Assembly who are at the front lines of managing water disputes in California.

The Pacific Council's Global Water Scarcity Project is committed to building the capacity of individuals and policymakers to anticipate, prevent, and resolve transboundary water disputes. Our Local Field Forays give us an opportunity to connect global issues, such as water scarcity, to local contexts. On each trip, we design experiences to foster closer ties between our member community and the local leaders, thinkers, partners, and institutions that are shaping our world.

Please note that space on this trip is limited and registrations will be taken on a first-come, first-served basis.

 - o Ground transportation on October 23 from the State Capitol to the River Delta & afternoon/evening meetings & meals

- All substantive meetings for the trip will take place on Tuesday, October 23. Should delegates wish to stay longer, we will be hosting an optional welcome dinner on the evening of October 22 & a social breakfast the morning of October 24 – both will be within walking distance of the Capitol
