TRIP INFORMATION

The Pacific Council's Water Scarcity Initiative seeks to identify global solutions to water challenges to end water scarcity as we know it. This Local Field Foray to Carlsbad and San Diego will explore water scarcity, conservation, and management issues as they relate to both the San Diego water basin and to broader global water challenges. Members will have the opportunity to tour the Claude "Bud" Lewis Carlsbad Desalination Plant* and the Encina Water Pollution Control Facility, as well as to connect with policy experts at the San Diego County Water Authority.

The Pacific Council's Local Field Forays visit local sites of global policy interest. Each trip aims to deepen our understanding of key international issues as they relate to the local community – ranging from international trade and the Port of Los Angeles to the U.S.-Mexico border and immigration. These trips are designed to foster closer ties between our member community and the local leaders, thinkers, partners, and institutions that are shaping our world.

**Please note that the Carlsbad Desalination plant consists of an approximately one (1) mile walking tour that includes climbing stairs and walking on some uneven surfaces.*

TRIP OVERVIEW:
